DPHS Program Features the History of Capistrano by the Sea Hospital on May 18

The Dana Point Historical Society will have its next meeting on **Wednesday, May 18**, in council chambers located in Dana Point City Hall. ***Dana Point's Dolphin House: The Lost Years of Capistrano by the Sea Hospital (1979 to 1998)*** will feature a presentation by a panel of former Capistrano by the Sea Hospital professionals sharing anecdotes and slides about the complex's evolution, programs and clientele, documenting the years the Dolph House was used as a free-standing psychiatric hospital prior to being restored as a single family home. A Q&A period will end the program.



The event starts promptly at **7 p.m.** and will have Marc Skelton PhD, Sarah Steinmeyer PhD, Jay Bruhl, RN, Barry Havlik, MA, Dee Goodfellow, LCSW and Maria Ricaurte, LISW (via remote) as featured speakers. A reception in our museum will follow the program.

A Hospital Revisited, and a Summer Salute to Sorrento



Our upcoming May meeting is the result of a Capistrano by the Sea Hospital & Clinic staff Zoom reunion of professionals who worked there from the late 1970s until the facility closed in 1998. It was in August 2021 when I returned a call to the museum from Dee Psychos Goodfellow, who subsequently emailed me c.1981 photos from Susan Griffin Van Leaven, a hospital employee. The photos were of the “Dolphin” house, the adolescent unit and the adult psych unit. Dee commented that it seemed like there were Eucalyptus trees everywhere, but there was one large grassy expanse with a gazebo overlooking the harbor. She also sent a photo of Dr. Charles O. “Tony” Sturdevant, the hospital’s medical director during those years. As a result, I asked Dee if former staff members would consider presenting an oral history program about their years at the hospital for our members.

The 2002 Historic Resources Assessment to preserve the historic significance of the Dolph Residence by Steven Fader, Architect, divides the Dolph estate into three general periods: The Blanche Dolph Era, 1914-1945; the Capistrano by the Sea Hospital & Clinic era, 1953-1998; and the restoration as private residence 2003-2006, which continues to this day. We have very little recorded history about the hospital years. For our meeting, a distinguished professional panel has been organized whose members will fill in the blanks and share their experiences from a time when the oldest historic home in Dana Point was a free-standing psychiatric hospital and clinic.

According to Barry Havlik, MA, panel moderator, the topics to be discussed include: the establishment of Capistrano by the Sea Hospital by Dr. Harold E. Day, who purchased the property in 1953; the evolution of the various programs and treatment modalities; how the hospital and clinic were set apart from other psychiatric facilities; how the clinical staff counseled and educated clients; what was done to create interdisciplinary team building and staff morale; and the types of clientele in which it specialized.

The program starts promptly at 7:00 pm in City Council Chambers on Wednesday, May 18, and will be recorded. A wine & cheese reception will follow afterward in the museum.

The Historical Society is honored to be a sponsor of the newly formed Dana Point Sister Cities International Association fundraiser. The goal of the new nonprofit is to choose a sister city with which to exchange arts, culture and international goodwill. Our participation helps sponsor a worthwhile organization and also helps to raise money for our scholarship fund.

It is appropriate that the first fundraiser celebrates the cuisine and culture of Italy. Did you know that early investors in Sidney H. Woodruff’s 1920s Dana Point wanted to develop a seashore community inspired by Sorrento, Italy?

Dr. J. L. Beebe and his wife, H. Eva Beebe invested in Dana Point as early as 1923-24 and were among those who envisioned an elaborate hotel overlooking the Pacific Ocean with hundreds of Mediterranean-style homes and numerous recreational facilities. Sidney H. Woodruff arrived in 1925 and subdivided Dana Point in 1926. His plans also called for a yacht harbor, polo field, golf course and a luxurious hotel patterned after hotels along the cliffs of Sorrento, Italy. Woodruff started construction of the Dana Point Inn hotel in January 1930, to be finished for the 1932 Olympics in Los Angeles. Photographs in Woodruff’s investor and realtor albums, entitled *DANA POINT, The New Seacoast and Recreational Community on California’s South Shore*, compared the similarities of the Dana Point Headlands and coastline with Sorrento’s coastline. However, hotel construction stopped the same year it began due to the faltering economy caused by the stock market crash in October 1929.

The three remaining hotel arches on the historic Bluff Top Trail above the harbor and the Dana Point Inn elevator entrance below, on Harbor Drive, seek to remind us of the never-completed hotel. Dana Point Inn stock certificates, stationery and engraved silverware, ordered for the hotel but never used, are displayed in our museum. The 1980s Admiralty condominium development is on the grounds of the abandoned hotel foundation, originally built to overlook a planned harbor. It seems Sorrento, Italy, was an understated influence on our local history.
